# 2: Discussion: creating guidelines for BS, vs BA, vs specialized degrees (e.g., BBA, BSN).

- Typically, BS degrees require an additional math &/or science beyond the core; the math requirement is typically 110/111 instead of 105
- At most schools BA degrees require additional Humanities classes
- Specialized degrees are typically discouraged—less value for graduate study, too focused; sometimes required by licensure

- EDUC 413: Teaching Science in Early Childhood and Elementary Schools. "This course currently has co-requisites and admission to the COE as prerequisites. We are modifying the prerequisite to admission to the COE and EDUC 332 with a C or better."
- EDUC 420: Methods and Materials for Early Childhood Classroom. "This course currently has corequisites and admission to the COE as prerequisites. We are modifying the prerequisite to Admission to the COE and EDUC 423 with a C or better."
- EDUC 421: Methods for Classroom Management and Effective Instruction in Elementary Schools. This course currently has co-requisites and admission to the COE as prerequisites. "We are modifying the prerequisite to Admission to the COE and EDUC 423 with a C or better."
- EDUC 423: Assessment Reading/Strategies. "This course currently has co-requisites. We are modifying the prerequisite to admission to the COE and EDUC 332 with a C or better. EDUC 390 is a corequisite for ECE majors."

# HISTORY/POLITICAL SCIENCE:

POLI 450: Qualitative Research Methods in Political Science. Revise pre-req. "The current course
prerequisites have become an unnecessary advising complication and have bred the misconception
among students that MATH 213 is required for graduation as a political science major. The proposed
changes will simplify advising and reduce confusion, thus engendering a positive impact on
recruitment and retention." Revise Prerequisites to: A declared major of Political Science and POLI
101 AND 201; PSYC 301 (non-lab portion) or a statistics course approved by the department.

### HONORS:

 HNRS 213: Revise title (previously Honors Topics in Economics and Commerce) to Honors Topics in Business, Economics, and Leadership. Revise description to: "A critical study of current activities in business, economics, and leadership that affect the global marketplace. Students will recognize macroenvironmental trends and discuss the business, economic, and leadership principles which define and/or explain them." (No change to LAC status, prereq, and may still not be challenged."

# **III: SPECIAL TOPICS:**

# BUSINESS:

BUSI 480: Advanced Topics - International Business Exploration. (3). BUSI 480. Advanced Topics-International Business is an exploration of international management issues or other special topics related to the specific destination of the study tour. The course will include travel to a foreign country to observe business practices and examine indigenous management problems, and to meet with representatives of local businesses and other institutions. This three-credit experiential course is designed to expose graduate students to the fundamental principles and basic concepts of international business and management, with emphasis on national differences in economic/political/legal/cultural institutions, international operational processes, global business strategy formulation, ethics, and managing global teams and HR talents in a global business environment by witnessing first-hand the business and culture of a country outside of the United States. No business, profession, or industry of any size is immune from the global environment. Understanding first-hand the global economy! business is essential for all students engaged in business arid careers. With such rationale, this course broadly explores the interrelation of government and business across borders and the economic dynamics between countries/regions, including a general overview of the international monetary system, international trade and foreign direct investment. Students will be required to spend a minimum of one week learning about the culture and business practices in a country designated by the instructors.

## IV: COURSE DELETION

#### **PSYCHOLOGY:**

• PSYC 385. Comparative Animal Psychology. "We do not have qualified faculty available to teach this course and do not foresee being able to hire someone to do so." Impact: "[T]his will mean one less option in the Experimental area for the Major requirements. As we hire new faculty with different interests, we hope to replace this course with another option."

# Post-Meeting Email Amendment:

#### SPECIAL TOPICS:

- NURS 280: Special Topics--Diversity, Equity, and Inclusion in Nursing. (3). Pre: NURS 231 and Approval of Dean. This course allows students to explore a topic related to one of the American Association of Colleges of Nursing "Concepts of Nursing Practice," which include (1) clinical judgment, (2) communication, (3) compassionate care, (4) diversity, equity, and inclusion, (5) evidence-based practice, (6) health policy, and (7) social determinants of health. (Ethics is also one of the American Association of Colleges of Nursing "Concepts of Nursing Practice," however, it is not included as a topic for this course since there is a separate Ethical and Legal Issues in Healthcare elective course.) Topics may vary. Extended study and application through an approved project is required. This course cannot be challenged.
- NURS 480: Advanced Topics-- Improving the Patient Experience. (3). Pre: NURS 331 and approval of Dean. This elective course allows students to examine a contemporary nursing issue and create an innovative solution to improve nursing practice in the selected topic area. Topics vary and may include clinical decision-making, the patient experience, staffing shortages, workplace violence, telehealth, patient safety, and organizational culture. Extended study and application through an approved project is required. Interaction with experts in the nursing profession in local or regional health care organizations is required in the design of the course project. Students are responsible for their own transportation. This course cannot be challenged.

# **A:** Aeronautics Program Revisions

- i. Remove Military and Missionary Tracks. Because "Improved risk management and burden on faculty. Current Military and Missionary tracks are not attractive to Professional Pilot students due to high lab fees, lack of impact on military pilot ascension, and incomplete missionary pilot preparation. Similar programs at Liberty University account for less than 3% of the aeronautics department." 1 freshman student in Bridge Program who has not entered the major courses yet.
- ii. Revise "Professional Pilot" track: "Professional Pilot core courses adjusted in accordance with FAA Letter of Authorization B300-1 dated 20 Dec 22. R-ATP courses AERN 250 and AERN 380 were added. AERN 360 and AERN 361L were not approved by the FAA and have been removed as core requirements. R-ATP certification verbiage adjusted according the issued LOA. CSCI 210 preferred course catalog inclusion is confusing."
  - CSCI 210 is not the required CSCI LAC course
  - Add AERO 250 & AERO 380:
  - Delete AERO 360 & 361L.
  - Increases major by 4 hours to 66.

Professor Hiott motioned to approve. Dr. Perry seconded the motion. All approved.

# **B: Education Program Revisions**

- i. Early Childhood Education: Delete EDUC 391 from required classes, because "Praxis requirements have changed." Decreases major by 3 hours, from 72 to 69.
- ii. Elementary Education: Delete EDUC 391 from required classes, because "Praxis requirements have changed." Decreases major by 3 hours, from 69 to 66.

## NURSING:

"[M]oving Pathophysiology to Summer II this will allow Fundamentals of Nursing, Pharmacology, and Health Assessment to be offered over 15 weeks, rather than 7 weeks. Pathophysiology is a prerequisite or the above named courses. This would also allow the students more time to grasp the content in the fall courses, In hopes of increasing our retention. We will have an additional credit hour available (from the previous Pathophysiology course) to put in NURS 218 Fundamentals of Nursing. This will reflect the Traditional Program credit hours. This will also reflect the Traditional Program clinical hours with the transition to a 15 week course. Students would have an additional 42 clinical hours over the course of 15 weeks. They will have the opportunity to put the learned content into practice."

- minor keys; the ability to tap or sing rhythmic patterns. Musicianship 198L also begins an exploration of what it means to be a Christian musician."

This course "focuses on further developing the aural skills for singing elementary melodies and rhythms, and dictation of melodies, rhythms and harmonies in major and minor keys gained in Musi 198L with increasing levels of rhythmic, melodic, and harmonic nuance and complexity. Specifically, these aural skills involve the identification of intervals, all diatonic triad and seventh chord types, melodic lines of increased melodic and chromatic subtlety, scale familiarity, triad and seventh chord factor recognition; the identification of rhythmic patterns and errors in rhythmic patterns; the writing of dictated melodies, triads, diatonic progressions; the sight-singing of intervals, arpeggios, and melodies employing movable-do solfege in major and (do-based) minor keys, with an increasing presence of chromatic ornamentation and basic modulation to related keys; the ability to tap or sing rhythmic patterns. Musicianship 199L also continues the exploration of what it means to be a Christian musician."
- MUSI 298L: Aural Skills III. (1) Pre-requisite: MUSI 199L. Class "focuses on developing the aural skills for the singing and dictation of advanced melodies and rhythms, and advanced chromatic dictation of melodic and harmonic intervals. Specifically, these aural skills involve the identification of intervals, chromatic triad and seventh chord types, chromatic melodic lines, scales and modes, chromatic triad factors, the identification of complex rhythmic patterns and errors in complex rhythmic patterns, writing chromatic dictated melodies, chromatic triad and seventh chords, chromatic harmonic progressions, sight singing intervals, chromatic arpeggios, and chromatic melodies, and the tapping or singing of complex rhythmic patterns."
- MUSI 299L: Aural Skills IV. (1) Pre-requisite: MUSI 298L. "Musi 299L focuses on further developing the aural skills for the singing and dictation of advanced melodies and rhythms, and advanced chromatic dictation of melodic and harmonic intervals (in both tonal and non-tonal contexts). Specifically, these aural skills involve the identification of intervals, chromatic triad, seventh, and other chord types, chromatic melodic lines, scales and modes, chromatic chord factors, the identification of complex rhythmic patterns and errors in complex rhythmic patterns, writing chromatic dictated melodies, chromatic triad, seventh, and other chord types, chromatic harmonic progressions, sight singing intervals, chromatic arpeggios, and chromatic melodies, and the tapping or singing of complex rhythmic patterns."

# **Adaptation of BA/BS Guidelines**

## **Background**

In the fall of 2022, the Curriculum Committee (CC) and the General Education Committee (GEC) of Charleston Southern University (CSU) commissioned this combined sub-committee (SC) to analyze and categorize CSU's current Bachelor of Arts (BA) and Bachelor of Science (BS) programs so as to describe how CSU typically designs these curricula. This study focuses on the roles of 1) math, 2) science, 3) foreign languages, and 4) minors, and it intends to provide templates for how future BA and BS programs should be made or modified under the direction of the office of the Vice President of Academic Affairs (VPAA). As such, this SC analyzed CSU's 31 BA and 38 BS programs in online and residential formats.

# The Methodology

The SC focused only on BA and BS programs, so we did not examine any graduate, Bachelor of Business Administration (BBA), Bachelor of Science in Nursing (BSN), or Bachelor of Technology (BT) programs. With the remaining BA and BS programs, the committee established simple criteria that organized our main concerns.

- (1) In the area of Liberal Arts Core (LAC) math, programs that only required MATH 105 were graded as a 0. Programs that required MATH 110 or greater as a part of the LAC were graded as a 1.
- (2) In the area of LAC science, programs that only required the two lab sciences were graded as a 0. Programs that required more advanced courses or multiple courses for LAC lab sciences were graded as a 1.
- (3) In the area of LAC foreign languages, programs that only required the 1 semester of foreign languages were graded as a 0. Programs that required more than the 1 semester of foreign languages, such has requiring 3<sup>rd</sup> semester proficiency, were graded as a 1.
- (4) In the area of minors, programs that did not require a minor were graded as a 0. Programs that required a minor were graded as a 1.

As part of the analysis, CAPS programs had an identical profile, so we reduced our summary analysis to the non-CAPS programs.

## Proposed Guidelines for BA/BS Program Delineation

Programs can be categorized as fitting into one of the following four patterns.

- Traditional BS Programs that emphasize "extra" math and science
- Professional BS Programs that are aligned with industry/career expectations
- Traditional BA Programs that emphasize a minor and "extra" foreign languages.
- Professional BA Programs that are aligned with industry/career expectation

These four patterns create four major profiles for revised and new BA and BS programs that CSU's academic leadership can create. It also establishes standard expectations and questions for Deans and Chairs from the CC. Of course, deviations can and will be needed from these profiles, but CSU will be

able with clarity to examine the business reasons for such deviations so that academic quality can be strengthened rather than weakened.

The four major profiles as CSU functions today are depicted in these two tables:

# **Current Programs that Do Not Meet These Proposed Profiles**

The following existing programs do not follow the proposed four profiles.

- BA Applied Computing follows current Traditional BS profile
- BA Public Health no additional language or minor requirements
- BS Criminal Justice no additional math or science requirements
- BS Political Science no additional math or science requirements
- BS Social and Human Sciences no additional math or science requirements
- BS/BA Education programs designed to meet education standards
- BS College of Adult and Professional Studies (CAPS) no additional requirements for any category

## Alternate Proposed Guidelines for BA/BS Program Delineation: Aspirational Profiles

<u>If</u> the CC and the GEC of CSU want to emphasize the Christian Liberal Arts aspect of CSU as part of the University's value proposition, it could strengthen these standard paradigms in the following manner.

Four possible Aspirational BA and BS profiles that could strengthen our academic requirements:

- Traditional BS = High Math, High Science, and either High For. Lang or a Minor
- Professional BS = High Math and/or High Science, and either High For. Lang. or a Minor
- Traditional BA = Either High Math or High Science, High For. Lang. and a Minor
- Professional BS = Either High Math or High Science, High For. Lang and/or a Minor

#### Conclusion

General patterns already exist within CSU's current BA and BS programs. These observations give us a current set of profiles that allow us to examine the academic rigor in general of these LAC aspects of our degrees. We recommend the CC use these proposed profiles as a means of evaluating the appropriateness of the BS or BA designation. We also have recommended possible new profiles for new and revised BA and BS programs going forward. If the CC and GEC of CSU want to utilize profiles to standardize and improve academic rigor in the LAC areas, we believe the four current profiles and the aspirational profiles create possible standards for CSU.

These findings and recommendations have been reviewed and approved by the whole task force.

R-65 will need to be updated, with dean approval based on the dean of the major. However, the Committee decided that students could not take generally listed interdisciplinary minors which may not be supported online, but that departments should be encouraged to develop more online minors.

## I: <u>CATALOG CHANGES AND COURSE REVISIONS\*:</u>

AERONAU	TICS:

- AERN 390: Aviation Regulation. Revised pre-req (previously none) to require ENGL 112. Rationale: "AERN 390 is research and writing intensive. Students require a foundation of proper formatting and research skills before this course is attempted."
- AERN 470: Aviation Law. Revise pre-requisites (previously none), adding ENGL 112 and AERN 390.
   Rationale: "The Aviation Law course is comprised of many research and writing assignments. Additionally, in this 400-level course, the students are expected to have an understanding of aviation history and regulations."

## **II: NEW COURSES**

#### **MATHEMATICS:**

• MATH 403. Mathematical Research. (1). Pre: 15 hours of Mathematics @ 221 or higher level and permission of instructor. "A course of supervised research in an area of Mathematics. This course should acquaint the student with the research process of preliminary literature search, research, oral presentation, and literature reporting. This course cannot be challenged." Rationale: "We would like to add in this one-hour research course to give students credit for doing a research project with a faculty member. This will also allow students to get an ELR credit by participating in mathematical research similar to what they would experience in graduate school or professionally." *Note: Submitted for ELR approval as well.* 

### **III: PROGRAM REVISION**

### **AERONAUTICS:**

Aerospace Management. Remove CSCI 211 as required LAC computer science course. "CSCI 211 sections are
in demand and are exceeding capacity. According to the Computer Science Chair, 'CSCI 210, CSCI 215, and
217 cover the same computer science fundamentals, but with different mediums. I believe any of those would
work well for most majors.' Removal of this specific course requirement will allow students the freedom to
choose any LAC CSCI course."
