This dissertation considers the use of epideictic rhetoric—praise and blame—in three seventeenthcentury biblical epics by John Milton, Abraham Cowley, and Lucy Hutchinson. Although epideictic rhetoric is often described as a merely ceremonial form of speech, I argue that these three authors deploy epideictic rhetoric in affectively powerful ways for the sake of social critique and the spiritual formation of their readers. These authors' works demonstrate that epideictic speech is not only a disinterested or decorative use of language, but also a means of reshaping readers' affections.

Manuscripts in Progress

Epideictic Rhetoric and the Affections in Seventeenth-Century Biblical Epic. This monograph considers the use of epideictic rhetoric—persuasive speech of praise and blame—in John Milton's *Paradise Regained*, Abraham Cowley's *Davideis*, and Lucy Hutchinson's *Order and Disorder*. Previous studies of Renaissance rhetorical poetics have shown the centrality of rhetoric to early modern intellectual culture, but rhetorical criticism of early modern verse has tended to focus on deliberative and forensic rhetoric while treating epideictic rhetoric as merely ornamental or ceremonial language. In response, I argue that epideictic rhetoric is central to these poets' philosophies of language and persuasive aims as they seek to shape their seventeenth-century readers' perspectives on contested theological, political, and scientific questions. I currently have a full draft and I plan to submit this manuscript to Palgrave Macmillan by the end of 2022.

The Protestant Afterlife of Medieval Poetics. As a longer-term project in its early stages, this monographlength work in progress explores how early modern Protestant poetics has a much more nuanced engagement with medieval poetic theory—and its underlying theological aesthetics—than has always been recognized. Drawing on recently recovered poetry by early modern Protestant women such as Lucy Hutchinson and Elizabeth Melville alongside work by authors long treated as canonical, this project shows the widely diverging ways that early modern English Protestant authors negotiated their inheritance of medieval poetics, theology, and Scholastic philosophy within literary forms such as biblical epic, dream-vision, prose meditations, and lyric verse.
