






RON AND MARCIA BRANTLEY

We appreciate what CSU does to repair the world.




DR. DONDI AND VICKEY COSTIN

How much of your success postgraduation was due to your education at CSU? That is the question that I finally asked myself in 2014.

First, my high school grades were weak, and no four-year college I applied to in 1965 had any interest in me attending their school. Because of that, I went to a junior college and had my first awakening. I realized that I was smarter than my high school grades indicated I was and found that I had a natural ability to learn accounting. After two years in junior college, I was ready to pursue a four-year degree, but four-year colleges weren't interested in me.

Fortunately, someone told me about CSU, (Baptist College at the time) and they were willing to give me a try. Overall, I made very good grades at CSU and broadened my education and matured.

Upon graduation, I defied the odds again by going to work in accounting for the largest textile company in the world at that time and received many promotions and opportunities over the years. Those opportunities eventually led me to being Chief Financial Officer for two different billion-dollar public companies.

After choosing to leave corporate America in 2003, I went into consulting and helped lead efforts to save a struggling \$4 million organic food company. Because they couldn't afford to pay me initially, I took stock in the company and sales over the next 10 years grew to over \$100 million only to see the CEO of the company try to deprive me of the true value of the company's stock that I owned. This was particularly hard on me because the CEO would not make a major decision without my input for many years.

We went through a long legal process and ultimately reached a settlement in 2014 that led to my second awakening – How did I get from a kid that barely graduated high school to a successful business man.

The answer was the Christian upbringing that my mother instilled in me, and I know that I have had the success I have because of GOD leading me to CSU and the success I have enjoyed in the business world.

Now you know why I have been a Presidential Council member of the Board of Visitors since 2014.

He represented the international scope of Graham's evangelistic ministry at Dr. Graham's funeral.

Dr. Billy Kim faithfully supports and prays for Charleston Southern University, believing in the power of one person. He will continue to pray that God bless all CSU staff and students and keep them in the hollow of His hands.
